We do not shampoo or blow dry hair on the day of the wedding.

Don't forget to wear button up or zip up shirt and bring your veil and headpiece.

*BOTG requires a minimum of 30 minutes per application for each service. Depending upon the amount of time designated by the purchaser for any services to be completed, in its discretion, BOTG may determine that additional hair or makeup artists will be required. If additional hair or makeup artists are required, an additional fee of \$50.00 per artist will be charged. Additional requirements, provisions, add on's or remarks:

If the event is canceled less than thirty (30) days prior to the day and time of the event, the purchaser agrees to pay BOTG the full amount of contracted services to BOTG. Any remaining balance is due and owing at the time of cancellation. * Initial ______ ALL DEPOSITS ARE NON-REFUNDABLE.

If any action at law or in equity is brought to enforce or interpret the provisions of this agreement, the prevailing party shall be entitled to reasonable attorney's fees in addition to any other relief to which he or she may be entitled. The validity of this agreement and of any of its terms or provisions, as well as the rights and duties of the parties, shall be governed by the laws of the State of Texas. It is agreed that the venue for any disputes pertaining to this agreement shall be Travis County, Texas. In the event that any one or more of the provisions contained in this agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provisions, and the agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained in it.
